The Greenland Chess Federation, founded on December 1, 2014, hereby formally applies for affiliate membership of FIDE. Our goal is to establish a widespread chess culture and introduce chess to both old and young people in Greenland, while also participating in international events and organizations.

Chess, while very new in its organized form, has a surprisingly long connection to Greenland. The famous Lewis chessmen, a collection of medieval chess pieces, have been definitively proven to be crafted from walrus tusks of Greenlandic origin<sup>1</sup>.

Modern chess, as already mentioned, has a relatively short history in Greenland. The first international tournament was held in 2003, attracting both Grandmasters and amateurs. Since 2003, international tournaments and chess club formation have been facilitated by the Icelandic chess club Hrókurinn, leading to a surge in Greenlandic chess activity. Interest in chess has grown significantly in recent years, and the Greenland Chess Federation (KNSK) sees many opportunities for the future.

# Statutes

Kalaallit Nunaanni Skakkertartut Kattuffiat  
Grønlands Skakforbund  
The Greenlandic Chess Federation

## § 1. NAME

The federation's name is Kalaallit Nunaanni Skakkertartut Kattuffiat (KNSK) with the bynames "Grønlands Skakforbund" and "The Greenlandic Chess Federation". The federation's address and its registered office is the chairman's address.

## § 2. PURPOSE

The objectives of the Greenland Chess Federation are:

- a. To be a non-profit nationwide organisation for all chess clubs in Greenland.
- b. To strengthen Greenlandic chess and work for the interests of Greenlandic chess players, both in and outside Greenland.
- c. To support cooperation with chess players from other countries.

## § 3. MEANS

In order to achieve the federation's purpose it is sought, as far as possible, to fulfill:

- a. Holding individual, team and correspondence tournaments.
- b. Membership of Fédération Internationale des Échecs (FIDE), The Nordic Chess Federation, Confederation of Chess for Americas (CCA) and International Correspondence Chess Federation (ICCF) and participation in tournaments organised by these.

## § 4. MEMBERSHIP

KNSK is a democratic federation and does not discriminate based on race, colour, sex, language, religion, political or other opinions, social origin, property, birth origin or any other status. All KNSK services are available to all members of the federation without exception.

Any Greenlandic chess player or Greenlandic chess club can become a member of the federation. Where special reasons, especially of a national nature, speak for it, members from outside Greenland may be admitted to the federation. Admission requires the consent of the board. A person automatically gains membership by joining a chess club that is a member of the federation. The federation maintains a membership register.

## § 5. ECONOMICS AND MEMBERSHIP FEE

The federation's funds consist of:

- a) Annual membership fees
- b) Any public subsidies
- c) Donations and private assistance that the federation may receive
- d) Other means not prohibited by laws and regulations; for example tournament fees paid directly to KNSK

The clubs pay dues according to the number of members, and the dues are paid annually by the treasurer for each individual club. If a club falls into arrears, membership of the federation can be revoked. A person who is excluded by a club due to arrears cannot be registered with the federation, unless the club and the federation waive the amount owed.

The federation's financial year starts on 1 January each year. Annual accounts are sent to the member clubs and published no later than 14 days before the general assembly.

## § 6. THE BOARD OF DIRECTORS

The federation's board consists of five persons: a chairman, a deputy chairman, a secretary, a treasurer and an ordinary member. The board distributes functions and tasks upon constitution.

## § 7. ORDER OF BUSINESS

The chairman calls board meetings. If the chairman is absent or otherwise prevented, the deputy chairman assumes the chairman's role.

The board meeting has a quorum when at least four board members or alternates are present. In case of disagreement on decisions, the matter is decided by voting. In the event of a tie, the chairman's vote is decisive.

The board determines the federation's work and purpose, in addition to the decisions made at the general assembly.

## § 8. GENERAL ASSEMBLY

The general assembly is the federation's highest authority. The general assembly is normally held once a year, no later than 1 July, and exceptionally when the board, or members representing at least 30% of the total number of votes, so request.

The deadline for submission of proposals for inclusion on the agenda is 28 days prior to the general assembly at the latest.

Convocation, accompanied by the agenda, is made by the board with at least 14 days' notice.

Anyone who is a member of the federation through a club or as a personal member has the right to participate in the general assembly.

Every participant has one vote.

Decisions at the general assembly are adopted by a simple majority.

At the ordinary general assembly, the chairman gives a report and the treasurer presents the accounts.

The board and deputies are elected at the general meeting. Elections are valid for 3 years at a time. In odd-numbered years, the chairman and one member and a deputy are elected, in even years the treasurer and 2 members and a deputy.

The board prepares a report of the general assembly's proceedings and decisions. The minutes are published no later than 2 months after the holding of the general assembly.

A personal member or a club that is a member of the federation, with debts to the federation, does not have the right to participate in the general assembly.

The general assembly determines the membership fee.

## § 9. VIRTUAL MEETINGS

Due to the special Greenlandic conditions regarding the difficult challenges in the transport infrastructure, board meetings and general assembly meetings can take place as virtual meetings — either in the form of time-shifted meetings, where decisions and submissions are made in the form of an email correspondence, or as online meetings in real time.

## § 10. EXCLUSION AND QUARANTINE

The General assembly has the right to exclude a club or a person who, at its discretion, opposes the interests of the federation.

Violation of the federation's statutes and rules, as well as behavior contrary to general decency and good sportsmanship, such as withdrawing without real reason during a chess tournament, insulting or derogatory mention of other chess players, may result in a penalty, warning or temporary ban from participation in tournaments.

## § 11. HONORARY MEMBERS

The general assembly can appoint honorary members on the recommendation of the board.

## § 12. AMENDMENTS TO STATUTES

Changes to the federation's statutes must be approved at the general assembly, and must be announced in the notice to the general assembly. Amendments to the federation's articles of federation are only valid if they achieve  $\frac{2}{3}$  of the votes cast.

## § 13. DISSOLUTION

In the event of termination, the federation's assets must be transferred to another association, fund, foundation, institution, etc. who are domiciled in Greenland and who have a charitable or otherwise non-profit purpose. Dissolution of the union requires a majority of 4/5 of the votes cast. For the union's debts, the clubs are liable to the creditors in proportion to their membership.

## § 14. INTERPRETATION OF STATUTES

The statutes are interpreted by the Greenland Chess Federation.

## § 1. NAVN

Forbundets navn er Kalaallit Nunaanni Skakkertartut Kattuffiat (KNSK) med tilnavnene "Grønlands Skakforbund" og "The Greenlandic Chess Federation".

Forbundets adresse og dens hjemsted er formandens adresse.

## § 2. FORMÅL

Grønlands Skakforbunds formål er:

- a. At være almennyttig landsdækkende organisation for alle skakklubber i Grønland.
- b. At styrke grønlandsk skak og arbejde for grønlandske skakspilleres interesser, både i og uden for Grønland.
- c. At støtte samarbejde med skakspillere fra andre lande.

## § 3. VIRKEMIDLER

For at nå forbundets formål søges det, så vidt muligt, at opnå:

- a. Afholdelse af enkeltmands-, hold- og korrespondance turneringer.
- b. Medlemskab af Fédération Internationale des Échecs (FIDE), Nordisk Skakforbund, Confederation of Chess for Americas (CCA) og International Correspondence Chess Federation (ICCF) og deltagelse i turneringer arrangeret af disse.

## § 4. MEDLEMSKAB

KNSK er et demokratisk forbund og diskriminerer ikke baseret på race, hudfarve, køn, sprog, religion, politiske eller andre holdninger, social oprindelse, ejendom, fødselsoprindelse eller nogen anden status. Alle KNSK-ydelser er tilgængelige for alle forbundets medlemmer uden undtagelse.

Enhver grønlandsk skakspiller eller grønlandsk skakklub kan blive medlem af forbundet. Hvor særlige grunde, navnlig af national karakter, taler for det, kan medlemmer uden for Grønland

optages i forbundet. Optagelse kræver samtykke fra bestyrelsen. En person opnår automatisk medlemskab ved at tilmelde sig en skakklub, der er medlem af forbundet.

Forbundet fører et medlemsregister.

## § 5. ØKONOMI OG KONTINGENT

Forbundets midler udgøres af:

- a) Årlige medlemskontingenter,
- b) Eventuelle offentlige tilskud,
- c) Donationer og privat bistand, som forbundet måtte modtage,
- d) Andre midler, der ikke er forbudt i henhold til love og regler; for eksempel turneringsgebyrer betalt direkte til KNSK

Klubberne betaler kontingent efter antallet af medlemmer, og kontingentet indbetales årligt af kassereren for hver enkelt klub. Kommer en klub i restance, kan medlemskabet af forbundet ophæves. En person, der er udelukket af en klub på grund af restancer, kan ikke være tilmeldt forbundet medmindre klubben og forbundet eftergiver det skyldige beløb.

Forbundets regnskabsår starter 1. januar hvert år. Årsregnskab udsendes til medlemsklubberne og offentliggøres senest 14 dage før generalforsamlingen.

## § 6. BESTYRELSEN

Forbundets bestyrelse består af fem personer: en formand, en næstformand, en sekretær, en kasserer, samt et menigt medlem. Bestyrelsen fordeler funktioner og opgaver ved konstituering.

## § 7. FORRETNINGSORDEN

Formanden indkalder til bestyrelsesmøder og er ordstyrer. Er formanden fraværende eller på anden måde forhindret, varetager næstformanden formandens rolle.

Bestyrelsesmødet er beslutningsdygtigt, når mindst fire bestyrelsesmedlemmer eller suppleanter er til stede. I tilfælde af uenighed om beslutninger afgøres sagen ved afstemning. Ved stemmelighed er formandens stemme afgørende.

Bestyrelsen fastlægger foreningens arbejde og formål, udover de beslutninger der træffes på generalforsamlingen.

## § 8. GENERALFORSAMLING

Generalforsamlingen er forbundets højeste myndighed. Generalforsamlingen afholdes normalt én gang årligt, senest den 1. juli, og ekstraordinært når bestyrelsen eller medlemmer, der repræsenterer mindst 30 % af det samlede antal stemmer, forlanger det.

Fristen for aflevering af forslag til optagelse på dagsordenen er senest 28 dage før generalforsamlingen.

Indkaldelse, ledsaget af dagsordenen, foretages af bestyrelsen med mindst 14 dages varsel.

Enhver, der er medlem af forbundet, gennem en klub eller som personligt medlem, har ret til at deltage i generalforsamlingen.

Hver deltager har en stemme.

Beslutninger på generalforsamlingen træffes ved simpelt flertal.

På den ordinære generalforsamling aflægger formanden beretning, og kassereren fremlægger regnskab.

Bestyrelsen og suppleanter vælges på generalforsamlingen. Valg gælder for 3 år ad gangen. I ulige år vælges formanden og et medlem samt en suppleant, i lige år kassereren og 2 medlemmer samt en suppleant.

Bestyrelsen udfærdiger et referat af generalforsamlingens forhandlinger og beslutninger. Referatet offentliggøres senest 2 måneder efter generalforsamlingens afholdelse.

Et personligt medlem eller en klub der er medlem af forbundet, med gæld til forbundet, har ikke ret til at deltage i generalforsamlingen.

Generalforsamlingen fastsætter kontingentet.

## § 9. VIRTUELLE MØDER

På grund af de særlige grønlandske forhold omkring de svære udfordringer i transportinfrastrukturen, kan bestyrelsesmøder og generalforsamlinger foregå som virtuelle møder — enten i form af tidsforskudte møder, hvor beslutninger og indlæg udfærdiges i form af email-korrespondance eller som online møder i realtid.

## § 10. EKSKLUSION OG KARANTÆNE

Generalforsamlingen har ret til at ekskludere en klub eller en person, som efter dens skøn modarbejder forbundets interesser.

Overtrædelse af forbundets vedtægter og regler samt adfærd, der strider imod almen anstændighed og god sportsånd, såsom at trække sig uden reel grund under en skakturnering,

fornærmelig eller nedsættende omtale af andre skakspillere, kan medføre en straf, advarsel eller midlertidigt udelukkelse fra deltagelse i turneringer.

## § 11. ÆRESMEDLEMMER

Generalforsamlingen kan udnævne æresmedlemmer efter indstilling fra bestyrelsen.

## § 12. VEDTÆGTSÆNDRINGER

Ændringer i forbundets vedtægter skal godkendes på generalforsamlingen, og skal meddeles i indkaldelsen til generalforsamlingen. Ændringer i forbundets vedtægter er kun gyldige, hvis de opnår  $\frac{2}{3}$  af de afgivne stemmer

## § 13. OPLØSNING

Forbundets aktiver skal i tilfælde af ophør tilfalde en anden forening, fond, stiftelse, institution m.v. der er hjemmehørende i Grønland og som har et almenvelgørende eller på anden måde almennyttigt formål. Til opløsning af forbundet kræves et flertal på 4/5 af de afgivne stemmer. For forbundets gæld hæfter klubberne over for kreditorerne i forhold til deres medlemstal.

## § 14. FORTOLKNING AF VEDTÆGTER
