Aurélien was at the Rabat international universities chess tournament. Almost one of us should improve this training. This one will be the Federation's responsible for Chess in Education in the future. Because we have not this responsibility in our Executive Board now according to our statutes.

The Burkinabe Chess Federation's objectives are: - To organize and develop the practice of chess in Burkina Faso. - To bring together, guide, and supervise all associations practicing chess in a spirit of solidarity, inclusion, equality, and fair play. - To practice transparent, democratic, and egalitarian management. - To maintain all useful relationships with other sports organizations, partners, and public authorities. - To worthily represent Burkina Faso nationally and internationally. - To create a framework for the education and development of Burkinabe youth. - To work with its peers in Mali and Niger to promote fraternal cooperation within the framework of the AES. - To represent Burkina Faso in international organizations (FIDE, African Chess Federation, AIDEF). - To actively contribute to making Chess a sport for girls as much as for boys.
What are your expectations from becoming a FIDE member?	Allow us to get FIDE ID for all our players without having to beg for it. Allow us to ask the former body that was approved by FIDE to give us the materials they received from FIDE but never were distributed among players or clubs. The recognition we have done a huge amount of work without resources and that we have future.
Please add any points not covered above that you would like to add.	We are not happy about the fact that we had to pay the arrears of the former FIDE-recognized body in Burkina Faso, the CNBE, only to find ourselves in a situation of dependence on a reverse delegate. It was unfair to us barely born, we were threatened with suspension, ordered to pay to avoid this, and then put under guardianship. Fortunately, our reverse delegate was a wonderful person. But FIDE should be co-responsible for the arrears accumulated, and in the case of a completely different new and democratic federation (the previous one was not), the debts should have been forgiven.

PART I – STATUTES

PREAMBLE

Invented in India, transformed in Persia (Iran), modernized by the Arabs, and later introduced to Europe, chess was initially the game of kings before becoming popularized and played by millions of people around the world — in families, among friends, in public places, in clubs, tournaments, by correspondence, against computers, and today, above all, online.

Chess has been recognized as a sport by the International Olympic Committee since 1999, and the current World Champion is the Chinese Grandmaster Ding Liren (since 2023).

Chess is the best sport to train the most important organ in our body: the brain. It is a mental discipline that develops observation and analytical skills, deductive reasoning, foresight, creativity, perseverance, character strength, respect for opponents and rules, logical rigor, and critical thinking.

Throughout history, many eminent figures have been passionate chess players — from Napoleon to Che Guevara, from Thomas Sankara to Vladimir Putin.

Playing chess fosters creativity more than any other activity. It enhances problem-solving skills (and mathematics performance), memory, and reading comprehension. Every move has a consequence, good or bad. Thinking carefully before making a move and executing it on the board provides deep satisfaction. Acting hastily, on the other hand, can lead to frustration.

By studying one's games, participating in competitions, and analyzing losses to identify weaknesses, the player develops confidence and resilience. Winning and losing become life lessons — this is why chess has the power to bring people together.

TITLE I – CONSTITUTION, NAME, DURATION, OBJECTIVES, NATURE AND AFFILIATION

Article 1 – Constitution

Under the High Authority of the Ministry of Sports of Burkina Faso and in accordance with the official directives issued for this purpose, chess clubs, chess sections within multi-sport clubs, and regional chess structures (Leagues and Districts) that adhere to these Statutes have decided to establish the **Burkina Faso Chess Federation (FBJE)**.

The Federation is created pursuant to **Law No. 050-2019/AN of 21 November 2019** (Law on the orientation of sports and leisure) and **Decree No. 2004-511/PRES/PM/MSL of 17 November 2004**, concerning the organization and attributions of national sports governing bodies.

Article 2 – Name

The Federation established under Article 1 shall be known as the **Fédération Burkinabè de Jeu d'Échecs (FBJE)**, hereinafter referred to as the **Burkina Faso Chess Federation**.

Its official acronym is **F.B.J.E.**

Article 3 – Duration

The duration of the Federation is **ninety-nine (99) years**, except in the case of early dissolution decided in accordance with these Statutes.

Article 4 – Registered Office

The registered office of the Burkina Faso Chess Federation is located in **Ouagadougou**, capital of the province of **Kadiogo**.

It may be transferred to any other location within Burkina Faso by decision of the Executive Board, ratified by the General Assembly.

Article 5 – Objectives

The Burkina Faso Chess Federation pursues the following objectives:

- To organize and develop the practice of chess throughout Burkina Faso;
 - To unite, guide, and supervise all chess associations in a spirit of solidarity, inclusion, equality, and fair play;
 - To ensure transparent, democratic, and equitable management;
 - To maintain cooperative relations with other sports organizations, partners, and public authorities;
 - To represent Burkina Faso with dignity at the national and international levels;
 - To create a framework for the education and development of Burkinabè youth;
 - To collaborate with its counterparts in Mali and Niger to promote fraternal cooperation within the framework of the **Alliance des États du Sahel (AES)**;
 - To represent Burkina Faso within international organizations (**FIDE, African Chess Confederation, AIDEF**);
 - To promote chess equally among **girls and boys**, making it a sport accessible to all.
-

Article 6 – Nature

The Burkina Faso Chess Federation is **non-political, secular, and non-profit**. It operates on **democratic principles** and prohibits all forms of discrimination. Any violation of this rule may result in suspension or expulsion.

Article 7 – Affiliation

The FBJE shall be affiliated with the **International Chess Federation (FIDE)** and shall comply with its statutes, rules, and regulations, as well as with the national sports laws and regulations of Burkina Faso.

TITLE II – MEMBERS

Article 8 – Categories of Members

The FBJE is composed of the following categories of members:

- **Active members,**
 - **Honorary members,**
 - **Benefactor members.**
-

Article 9 – Active Members

Active members are chess clubs and associations affiliated with the FBJE. Chess sections within multi-sport clubs are considered as chess clubs.

To be recognized as active members, such associations must:

1. Possess an official certificate of registration (or a record of establishment attached to the parent club's registration);
 2. Pay the required membership or affiliation fees to the FBJE;
 3. Regularly participate in FBJE competitions and activities;
 4. Send representatives to attend the Federation's administrative meetings;
 5. Through their members, participate in national online tournaments organized on **Chess.com** or **Lichess.org** within the Burkina Faso team.
-

Article 10 – Honorary Members

The title of **Honorary Member** may be conferred by the **General Assembly**, upon recommendation of the **Executive Board**, on persons who have rendered exceptional services to the FBJE.

Article 11 – Benefactor Members

The title of **Benefactor Member** may be granted by the **General Assembly**, upon recommendation of the **Executive Board**, to any individual or legal entity providing regular financial or material support to the Federation.

Article 12 – Admission of New Members

Any chess association established in accordance with the laws of Burkina Faso and adhering to these Statutes and Internal Regulations may apply to the Executive Board for **provisional affiliation**.

The Executive Board shall decide on such applications within one (1) month.
Final affiliation shall be granted by the **General Assembly** upon recommendation of the Executive Board.

Article 13 – Loss of Membership

Membership in the FBJE may be lost:

- For leagues, districts, clubs, or sections:
by resignation, dissolution, withdrawal of legal recognition, or expulsion decided by the General Assembly or the competent public authorities.
Such expulsion may not take effect without prior notice to the Directorate of Physical and Leisure Activities, remaining unanswered for 30 consecutive days.
 - For honorary members:
by voluntary resignation, removal by the General Assembly, or death.
 - For benefactor members:
by resignation, death, non-payment of contributions for an extended period, or removal by the General Assembly.
 - For all members:
by **temporary suspension** decided by the Executive Board for serious violations of these Statutes or the FBJE regulations, or for conduct prejudicial to honor or ethics.
Suspended members shall be invited to provide explanations and may appeal to the General Assembly.

TITLE III – ORGANIZATION, ADMINISTRATION AND OPERATION

Article 14 – Organs of the FBJE

The FBJE comprises **two governing bodies** and **two executive organs**:

Governing Bodies:

- a) The General Assembly
- b) The Management Council

Executive Organs:

- a) The Executive Board
 - b) The Audit Committee (Commissioners for Accounts)
-

SECTION I – THE GENERAL ASSEMBLY

Article 15 – Role and Powers

The **General Assembly (GA)** is the supreme decision-making body of the FBJE. It defines the Federation's policy for the management, development, monitoring, and evaluation of chess nationwide.

It shall:

- Approve the financial report and annual accounts;
- Grant discharge to the Executive Board for its financial management;
- Approve the Executive Board's activity reports and programs;
- Adopt the action plan and financial plan;
- Approve affiliations, resignations, and suspensions;
- Elect the Executive Board and the Auditors.

The General Assembly meets **once every two (2) years** and is chaired by a person **not belonging to the Executive Board**, assisted by a session secretary who is also not a member of the Executive Board.

Article 16 – Composition

The General Assembly is composed of:

- Members of the Executive Board;
- Honorary and benefactor members;
- Commissioners for Accounts;
- The National Technical Director;
- One (1) representative per League and per District;

- One (1) representative per affiliated club;
- Delegates from technical or regional commissions;
- Burkinabè members of international, continental, or subregional sports organizations;
- Representatives of the Ministry of Sports and Leisure;
- Representatives of the National Olympic and Sports Committee of Burkina Faso (CNOSB).

Note: Only delegates representing clubs, leagues, and districts holding valid registration certificates have the right to vote.

Article 17 – The Management Council

The **Management Council** monitors the Federation’s activities during years when the General Assembly does not convene.

It shall:

- Validate financial and activity reports;
- Review the Executive Board’s accounts and approve programs;
- Supervise affiliations, resignations, and suspensions;
- Fill vacant positions when necessary;
- Ensure moral and administrative oversight of the FBJE’s management.

The Council meets **once per year** and is chaired by a non-member of the Executive Board, assisted by a non-member secretary.

Composition and voting rights are identical to those of the General Assembly.

SECTION II – THE EXECUTIVE BOARD

Article 18 – Nature and Composition

The **Executive Board** is the governing and administrative body of the FBJE. It exercises the powers conferred by these Statutes and by the General Assembly.

It consists of **sixteen (16) members**, including:

1. One (1) President
2. Two (2) Vice Presidents
3. One (1) General Secretary
4. One (1) Deputy General Secretary
5. One (1) General Treasurer
6. One (1) Deputy General Treasurer
7. One (1) Chairman of the Competition Committee
8. Two (2) Secretaries of the Competition Committee

9. One (1) Secretary for Organization
10. Two (2) Deputy Secretaries for Organization
11. One (1) Secretary for Communication and Information
12. One (1) Deputy Secretary for Communication and Information
13. One (1) Secretary for the Promotion of Women's Chess

The General Assembly may adjust the number of members in accordance with national sports governance regulations.

Article 19 – Term of Office

Members of the Executive Board are elected for a **two-year renewable term**.
In case of dysfunction, the General Assembly or Management Council may decide on an early renewal of the Board.

Article 20 – Meetings

The Executive Board meets **at least once every two (2) months**, and extraordinary meetings may be convened.

In the event of a tie, the **President's vote prevails**.

A quorum is reached when a simple majority of members is present.

Article 21 – Powers of the President

The President represents the Federation in all civil acts and before the courts.
He signs all official and financial documents, jointly with the General Treasurer when necessary.

He may delegate his authority to other Executive Board members as appropriate.

SECTION III – THE AUDIT COMMITTEE

Article 22 – Role

The Audit Committee is a control body composed of two Commissioners for Accounts elected by the General Assembly.

They are responsible for verifying the accuracy and transparency of the Federation's financial accounts and presenting a report to the General Assembly before the annual approval of accounts.

SECTION IV – ELIGIBILITY CONDITIONS

Article 23 – Candidacy

Candidates for Executive Board membership must:

- Submit a written candidacy at least one week before the Assembly;
- Enjoy their full civil rights;
- Be duly mandated by an affiliated club in good standing.

Elections are conducted by **secret ballot**, either **by list** (if a collective list is presented) or **individually** (if not).

SECTION V – ELECTION PROCEDURE

Article 24 – Voting

The General Assembly elects Executive Board members by **secret ballot** with:

- Absolute majority in the first round,
- Simple majority in the second round (limited to the top two candidates).

Vote counting is carried out publicly, and the results are proclaimed by the Presiding Officer.

Minutes are drafted and signed by the Presiding Bureau, with one copy filed with the Regional Sports Directorate.

TITLE IV – RESOURCES, FUNDS AND RESERVES

Article 25 – Fiscal Year

The fiscal year begins on **January 1st** and ends on **December 31st**.

Article 26 – Financial Resources

The Federation's resources consist of:

- Membership and affiliation fees;
- Income from competitions and events organized;
- Public or private subsidies;
- Sponsorships, donations, and legacies;
- Affiliation rights and FIDE/National ELO fees from players.

Article 27 – Membership Dues

Membership dues from clubs and associations are **mandatory**.
Their amounts and payment terms are set by the General Assembly.

TITLE V – AMENDMENTS TO THE STATUTES

Article 28 – Modification Procedure

Proposals to amend these Statutes may come from:

- The General Assembly or the Management Council,
- The Executive Board,
- A majority of affiliated clubs.

Amendments may only be decided by an **Ordinary General Assembly**, with at least **two-thirds (2/3)** of clubs represented and adopted by a **three-quarters (3/4)** majority of delegates present.

If this majority is not reached, the proposal may be re-examined the following year by the Management Council and validated definitively by the next General Assembly.

PART II – INTERNAL REGULATIONS

INTERNAL REGULATIONS OF THE BURKINA FASO CHESS FEDERATION (FBJE)

PREAMBLE

The present Internal Regulations specify and complement the Statutes of the Burkina Faso Chess Federation (FBJE).

They determine the practical and operational rules governing the functioning of the Federation, its bodies, and its affiliated members.

These Internal Regulations are adopted by the **General Assembly** of the Federation and have the same binding value as the Statutes.

They may be modified only by the General Assembly, upon proposal by the Executive Board or by at least one-third (1/3) of the affiliated members in good standing.

TITLE I – ORGANIZATION AND FUNCTIONING OF THE EXECUTIVE BODIES

Article 1 – Composition of the Executive Board

The Executive Board of the FBJE is composed of the following members:

1. The **President**
2. The **1st Vice President**
3. The **2nd Vice President**
4. The **General Secretary**
5. The **Deputy General Secretary**
6. The **General Treasurer**
7. The **Deputy Treasurer**
8. The **Secretary for Organization**
9. The **1st Deputy Secretary for Organization**
10. The **2nd Deputy Secretary for Organization**
11. The **Regional Development Secretary**
12. The **Secretary for the Promotion of Women's Chess**
13. The **Secretary for Communication and External Relations**
14. The **Two Auditors**

Each of these members performs specific duties and assumes moral and disciplinary responsibility before the General Assembly.

Article 2 – Duties of the President

The President is the legal representative of the Federation in all civil, administrative, and financial matters.

He/she:

- Ensures the implementation of the resolutions of the General Assembly;
- Coordinates the work of the Executive Board;
- Supervises relations with the Ministry of Sports and Leisure, the National Olympic Committee, FIDE, and other partners;
- Presides over all Executive Board and General Assembly meetings;
- Signs all official correspondence and financial documents of the Federation;
- May delegate part of his/her powers in writing to the Vice Presidents or General Secretary when necessary.

Article 3 – Duties of the Vice Presidents

The Vice Presidents assist the President in the performance of his/her duties and replace him/her in case of absence, according to rank.

The 1st Vice President coordinates the Federation's administrative and institutional activities.

The 2nd Vice President focuses on the development and expansion of chess activities nationwide.

Article 4 – Duties of the General Secretary

The General Secretary is responsible for the day-to-day administration of the Federation.

He/she:

- Drafts and signs all official correspondence jointly with the President;
- Maintains the Federation's records and archives;
- Prepares the minutes of all meetings;
- Ensures the proper transmission of information to members;
- Manages all official communication and documentation.

Article 5 – Duties of the Deputy General Secretary

The Deputy General Secretary assists the General Secretary and replaces him/her in case of absence or impediment.

He/she may also be specifically assigned to the management of online tournaments, digital records, or interclub correspondence.

Article 6 – Duties of the General Treasurer

The General Treasurer is responsible for the Federation's financial management.
He/she:

- Collects membership and affiliation fees;
- Prepares the annual budget and financial statements;
- Keeps accounting records and maintains supporting documents;
- Ensures the proper use of funds according to the Federation's objectives;
- Presents financial reports to the Executive Board and the General Assembly.

All financial operations must be jointly approved by the President and the General Treasurer.

Article 7 – Duties of the Deputy Treasurer

The Deputy Treasurer assists the General Treasurer in his/her duties and may temporarily replace him/her.

He/she ensures the availability and accuracy of all accounting documents and payment receipts.

Article 8 – Duties of the Secretary for Organization

The Secretary for Organization is responsible for the logistical coordination of all tournaments and official activities.

He/she ensures that competitions comply with FBJE and FIDE regulations and supervises relations with referees, arbiters, and host venues.

Article 9 – Duties of the Deputy Secretaries for Organization

They assist the Secretary for Organization in the preparation of events, handle tournament registrations, monitor scheduling, and manage reporting to the FIDE Rating Officer.

Article 10 – Duties of the Regional Development Secretary

The Regional Development Secretary ensures the promotion of chess in all provinces of Burkina Faso.

He/she establishes and maintains relations with clubs, districts, schools, and regional sports authorities to strengthen local structures.

Article 11 – Duties of the Secretary for the Promotion of Women’s Chess

The Secretary for the Promotion of Women’s Chess coordinates activities aimed at increasing the participation of women and girls in chess.

He/she proposes women’s tournaments, training sessions, and awareness programs.

Article 12 – Duties of the Secretary for Communication and External Relations

This Secretary is responsible for:

- The Federation’s public relations and media coverage;
 - The management of social media and the website;
 - The dissemination of official information;
 - International correspondence with partner federations and organizations.
-

Article 13 – Duties of the Auditors

The two Auditors are responsible for monitoring the Federation’s financial integrity.

They verify the accuracy of accounts and compliance with financial procedures.

They submit an annual audit report to the General Assembly.

TITLE II – MEMBERSHIP, FEES AND DISCIPLINE

Article 14 – Membership and Affiliation Fees

Membership and affiliation fees are determined annually by the General Assembly upon proposal of the Executive Board.

No club or player shall participate in official activities without being up to date with their financial obligations.

Article 15 – Player Registration

All chess players participating in official competitions organized or recognized by the FBJE must be registered.

Each player receives a **national identification code** and, if applicable, a **FIDE ID**. Registrations are managed by the Rating Officer and validated by the General Secretary.

Article 16 – Disciplinary Provisions

Any member, club, or official who violates the Statutes, Internal Regulations, or the ethical values of the FBJE may be subject to disciplinary measures, including:

- Warning;
- Suspension;
- Dismissal;
- Expulsion.

Disciplinary cases are reviewed by the Executive Board, which hears the accused and decides by simple majority.

Article 17 – Appeals

Any person sanctioned may appeal to the General Assembly within **15 days** following notification of the decision.

The General Assembly shall decide by secret ballot after hearing the explanations of all parties.

TITLE III – COMPETITIONS AND TOURNAMENTS

Article 18 – Organization of Competitions

All national competitions are organized by the FBJE or under its supervision. They include:

- The National Individual Championship;
- The National Team Championship;
- The Interschool and Inter-university Championships;
- Open tournaments organized by clubs with FBJE authorization.

Competitions must comply with **FIDE Laws of Chess** and **FIDE Competition Regulations**.

Article 19 – FIDE Rating and National Rating

All official competitions must be transmitted to the **FIDE Rating Officer** for international rating and to the **National Rating Officer** for local ranking. Players without a FIDE ID will automatically be registered in the national database before the event begins.

Article 20 – Tournament Reports

Organizers must submit a tournament report within **seven (7) days** after the competition.

This report must include:

- The list of participants and pairings;
- Results of each round;
- The names of arbiters and officials;
- A summary of incidents, if any.

Failure to comply may result in suspension of the organizer's future tournament approvals.

TITLE IV – EDUCATIONAL AND PROMOTIONAL ACTIVITIES

Article 21 – Chess in Schools

The FBJE promotes chess as an educational tool and collaborates with the **Ministry of Education** to implement the *Chess in Schools* program.

This program aims to introduce chess to at least **500 students per year** across the main regions of the country.

Article 22 – Training of Arbiters and Coaches

The Federation organizes periodic training sessions for arbiters, coaches, and organizers.

Certificates of qualification are issued upon successful completion of training courses validated by FIDE or the African Chess Confederation.

Article 23 – International Cooperation

The FBJE maintains relations with foreign chess federations, regional confederations, and international organizations for exchanges, tournaments, and development programs.

It may sign cooperation agreements with neighboring federations, particularly those of **Mali** and **Niger**, within the framework of the **AES (Alliance of Sahel States)**.

TITLE V – FINAL PROVISIONS

Article 24 – Interpretation

Any difficulty in interpreting these Internal Regulations shall be referred to the Executive Board, whose interpretation shall be subject to ratification by the next General Assembly.

Article 25 – Entry into Force

These Internal Regulations enter into force immediately after their adoption by the Constituent General Assembly held in **Ouagadougou on 2 June 2024**.

MINUTES OF THE ELECTIVE GENERAL ASSEMBLY OF THE BURKINABE CHESS FEDERATION

In the year 2024, on Sunday, June 2nd, at 11:10 a.m., the Elective General Assembly of the *Fédération Burkinabè de Jeu d'Échecs (FBJE)* was held at the Philagora High School, in the first classroom.

The agenda of the Assembly included the following points:

- Adoption of the Statutes and Internal Regulations
- Election of the Executive Board and the Auditors

The list of participants is attached to these minutes.

The General Assembly was held under the supervision of representatives of the Ministry of Sports, Youth and Employment: **Mr. YANOGO Adama**, **Mr. DEBE Blaise**, and **Mrs. ZONGO ZONABA Alxa**, all from the Directorate of Training and Regulation. Mr. YANOGO Adama and Mr. SANOU Gilbert (present in a personal capacity) gave advice and recalled key points of the directive to ensure that the proceedings were conducted in accordance with the regulations.

The *Presiding Bureau* of the Assembly, appointed by the General Assembly, was composed as follows:

- **President:** Saïdou KOÏTA
- **General Secretary:** S. Maurice. G. HOUNSOSSOU
- **Assessors:** Abdoul Aziz KOÏTA

Before addressing the agenda items, the President of the session verified the presence of members of the electoral college. According to the directive for establishing the Federation, the electoral college consisted of **8 electors** holding **12 votes**, distributed as follows: four votes for the Central Region League, two votes for the Boulkiemdé District, and one vote each for the six clubs with more than two years of existence.

After verification, all electors were present and presented their mandates (see attached mandates).

Adoption of the Statutes and Internal Regulations

The General Assembly unanimously adopted, with **12 votes out of 12**, the Statutes and Internal Regulations of the future Federation, subject to the inclusion of the amendments proposed by the representatives of the Directorate of Training and Regulation.

Election of the Executive Board of the FBJE

The President of the session reminded that, according to the directive, elections were to be conducted by list through a secret ballot.

The Assembly approved this procedure. The Presiding Bureau verified the candidacy lists. Only one list was presented (see annex).

The presence of all candidates on the list was checked; four candidates were absent but their absences were justified before the Assembly and the Presiding Bureau.

The candidate for the position of President, **Mr. Nicolas CARBONELL**, was invited to present his program before the vote.

Before his election, Mr. CARBONELL outlined his objectives to revive chess in Burkina Faso, which had been dormant for several years:

- Introduce chess in schools as an effective means of learning reflection and calculation.
- Establish a national ELO rating system and train coaches and arbiters to avoid reliance on foreign officials.
- Launch the *AES-Chess Project* with our brothers from Mali and Niger.
- Organize regular national competitions.

The Executive Board was elected unanimously by all the chess clubs and governing structures of Burkina Faso.

The electoral college proceeded to the vote of the single list.

At the end of the vote, the Executive Board was elected by secret ballot with **12 votes out of 12**.

FBJE ACTIVITY REPORT – SEASON 2024-2025

1. Introduction

The Burkinabe Chess Federation (FBJE), officially recognized by decree No. 096/MSJE/CAB of October 8, 2024, continued its mission of promoting and structuring chess in Burkina Faso during the 2024-2025 season. This year was marked by an intensification of school activities, the consolidation of national competitions, the development of clubs, and increased recognition at the international level. The main objectives set for this season were to strengthen communication (website and social networks), establish a national ELO system, structure clubs, develop practice in schools, organize national and international competitions, as well as consolidate partnerships with FIDE, AIDEF, and national stakeholders.

2. Competitions

The 2024-2025 season was particularly rich in competitions, both nationally and internationally. The Federation coordinated and supported numerous events that helped boost the sport and expand the player base.

2.1. In Ouagadougou

Numerous monthly and interclub tournaments were organized in emblematic places of the capital, notably at Lycée Vénégré, Lycée Bambata, Kamboinsin, Club Rosembourg, Club ADC, Chez Simon (central district and ZACA), Bangréogo Park, Maison Russe as well as Club Cavalier d'Or. The National Individual Championship, held in March 2025, brought together 41 participants from 9 clubs (Gambit de Saaba, Cheval Fou, Trois pions, Reine Déchue, SE de COKAD, SE de Kosyam Plus, SE de Komsilga, Elysée de Koudougou, Dafra de Bobo) from Kadiogo, Boulkiemdé and Houet. Nicolas Carbonell from COKAD emerged as champion, closely followed by Florian Bambara from Saaba's Gambit.

In the same month, the National Team Championship, organized at the CFPEM, brought together three teams – Gambit Chess Club of Saaba, Dafra Chess Club in Bobo-Dioulasso and Elysée Chess Club of Koudougou – and was won by the Gambit team of Saaba. Finally, in May 2025, the first inter-school competition brought together 40 students from eight schools in Bobo Ouaga and Koudougou, won by the Bobo team.

The national championships were:

- National individual championship (March 2025, CFPEM Ouagadougou) – 41 participants.
Winners: 1st Nicolas Carbonell, COKAD 2nd: Florian Bambara club.
- National team championship (March 2025, CFPEM Ouagadougou) – 3 teams (Saaba, Bobo, Koudougou). Winner: Saaba Gambit.
- First Inter-School Championship (May 11, 2025) – 40 students (accompanied by their parents/teachers = 80 meals served) from 8 establishments, won by Bobo.

After hard-fought games, three teams stood out:

1. ABC High School of Bobo-Dioulasso (4 points)
2. Saint-Exupéry High School in Ouagadougou (3.5 points)
3. Bouli Primary School in Kamboinsin (3 points)

This competition revealed the talent and potential of the next generation of Burkinabe chess players, while highlighting the role of educators and clubs in promoting the game.

2.2. In Bobo-Dioulasso

The city of Bobo-Dioulasso has hosted regular monthly tournaments at CEPRO. The Bobo Open, held in May 2025 in Ouezzin-ville, was the region's major event of the season. Details of the number of participants and full results remain to be announced.

- Children's Tournament (June 8, 2024, Dafra) – 17 participants.
- Bobo Open (May 2025, Ouezzin-ville) – more than 40 players, main event of the season.
- 72h of CPGE (July 25, 2025) – 70 students trained, blitz competitions.
- Regular monthly tournaments at CEPRO

2.3. In Koudougou

In Koudougou, the provincial tournament on November 30, 2024, marked a founding milestone. On August 9, 2025, the creation of the "Fou d'Or" club was formalized, followed by the organization of its first internal tournament on August 13. The club also took part in the Fair Play Night on September 13, 2025, demonstrating its dynamism.

- Provincial tournament (November 30, 2024) – first structuring stage.
- Creation of the Fou d'Or club (August 9, 2025).
- 1st Koudougou Open tournament (August 13, 2025).
- Participation tournament in the Nuit du Fair-play (September 13, 2025).

2.4. Internationally

Internationally, the FBJE has represented Burkina Faso at several events. In June 2025, two national teams participated in the Francophonie Blitz, with respectable scores, the details of which remain to be determined. Aurélien Tégawendé distinguished himself at the Rabat university tournament, placing 11th out of 82 players. However, participation in the West Africa Zonal (Nigeria) could not be held, despite the selection of a Burkinabe player. Finally, the International Francophone Chess Meetings (RIDEF), planned for Morocco, were suspended by the organizers.

- Francophonie Blitz (June 2025) – participation of 2 Burkinabe teams.
- Rabat University Tournament (June 2025) – Aurélien Tégawendé 11th out of 82.
- ANL-3 (August 2025) – Burkina 11th out of 25 African nations.
- AIDEF online tournament (June 2025) – Edmond Sanou: 7 wins out of 9, best performance Burkinabe.
- International Francophone Meetings (RIDEF, Morocco) – canceled by the organizers.
- Visit of GM Nigel Short (February 2025) – simultaneous against 22 players, strategic training, meetings with schools (Bouli, PMK and ISO) and with the Minister of Sports accompanied by the DGSL.

3. National and international projection

The FBJE has increased its visibility through the launch of the website www.fbje.org, supplemented by Facebook and Instagram pages. A national ELO system has been established, although limited for the time being to national championships. The structuring of clubs has continued with regular meetings and expansion projects, including the creation of a club in Kamboinsin and the merger of the Tampouy club with Kossyam+. A highlight was the visit of Grand Master Nigel Short in February 2025, which resulted in simultaneous meetings, training sessions, and official meetings, including an a Sports. The AES-Chess project, although slowed by insecurity in Niger, has maintained some online activities. The FBJE also participated in the Ministry of Sports' work to develop the national roadmap for sports and recreation, and obtained two official letters recognizing chess as an extracurricular activity for Basic Education and Secondary and Vocational Education, thus paving the way for the wider introduction of chess in public schools and high schools.

- Launch of the website www.fbje.org, Facebook and Instagram pages.
- Implementation of a national ELO (applied to championships).
- Structuring of clubs:
 - o Signing of an agreement with the Maison Russe to host a club and tournaments there.
 - o Prediction of non-renewal of Saaba's Gambit Club (its members will migrate to the Cheval Fou Chess Club).
 - o Tampouy/Kossyam+ merger forecast.
 - o Project to formalize the La Reine Déchue Chess Club in Kamboinsin
 - o Signing of a agreement with the Tangier Chess Club (Morocco)
- Humanichess Program (February-May 2025): training of IDP children from Kamboinsin, academic improvement observed over one term, especially in maths, recognized by FIDE.
- Participation in activities concerning all Federations (Ministry of Sports).
- Strategic partnership FBJE – Tangier Chess Club (Sept. 2025): “HISTORIC ALLIANCE, COMMON FUTURE – Play big, think further.
-

4. Training

Training remained a priority for the FBJE in 2024-2025. In Ouagadougou, seven School Instructors were trained by FIDE in April, followed by 25 school coaches trained in July by three Burkinabe Lead School Instructors. These sessions, organized online and in person, helped strengthen the network of trainers. Ten schools in the capital benefited from interventions, with teams being created in eight of them. The first inter-school competition brought together 40 students from these schools. The Humanichess program, aimed at internally displaced children, has shown a positive impact on their academic performance, particularly in

mathematics, and has been recognized by FIDE. In Koudougou, introductions to chess were carried out in several high schools (provincial, Sougrinooma, Saint-Marc, Shorge and modern technical). In Bobo-Dioulasso, training took place in three high schools and in Bérégadougou, with a view to creating a local club there.

- July 2024: 2 referees + 3 certified trainers.
- April 2025: 7 School Instructors trained by FIDE.
- July 2025: 25 school coaches trained by 3 Burkinabe Lead Instructors.
- July 2025: 4 FIDE certified Lead Instructors.
- August 2025: 27 national coaches trained.
- September 14, 2025: national training of school instructors, in connection with the school project.
- Allocation of schools for training in the 2025-26 school year (Sept. 2025): AMPO, Saint Exupéry, Bouli Succès, Yilegba, La Gospa, Elisa, ISO, Verdure.
- Local school activities:
 - o 10 establishments in Ouagadougou (8 teams created).
 - o Koudougou High Schools (Provincial, Sougrinooma, Saint-Marc, Shorge, Modern technical).
 - o 3 high schools in Bobo-Dioulasso.
 - o Awareness raising in Bérégadougou.

5. Financing, expenditure and resources

Funding was based on a grant of 500,000 FCFA from the National Fund, as well as one-off contributions from sponsors and donors such as CIM Métal (200,000 FCFA), Wend Konta (300,000 FCFA), COB Partners (100,000 FCFA), Chez Simon (50,000 FCFA), Presta-Son (66,000 FCFA), SKF (50,000 FCFA), Benoît d'Avout (125,000 FCFA), Sylvain Morand (40,000 FCFA), and Abib Radji (35,000 FCFA). These resources helped finance tournaments, communications, travel, accommodation for players from the provinces, and journalists' fees. Media activities were particularly costly, although the Federation received one-off discounts on certain channels. The equipment was reinforced thanks to the donation of chess sets by the Gift of Chess organization, 300 of which were reserved for the creation of clubs and school teams. As part of the Humanichess program, two collaborators were recruited: Saidou Koita, a salaried teacher for training in 3 public schools including the PMK, and Harouna Bandaogo, responsible for school canvassing, paid per establishment contacted and membership

effective.

6. Conclusions

The 2024-2025 season was marked by exceptional dynamism. The Federation was able to develop chess in schools, structure clubs, implement a national ELO system, and organize significant events such as the visit of GM Nigel Short. The Humanichess program confirmed the positive educational impact of chess, particularly among internally displaced children. However, the Federation faces structural challenges: a recurring lack of funding, the absence of a permanent headquarters and administrative staff, and security difficulties hampering territorial development and international participation. For 2025-2026, the FBJE intends to strengthen the structure of clubs, expand school participation, train more coaches and referees, and diversify its sources of funding. It will also continue to promote Burkina Faso's place on the chess scene.
