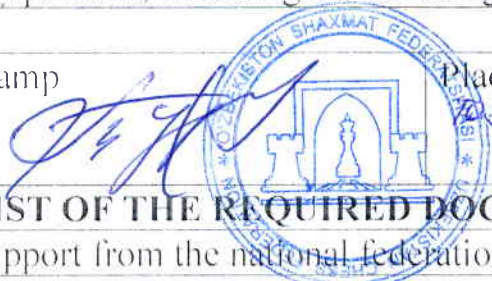
The Organiser undertakes to hold the Competition for Players with Physical Disabilities in one of the Official hotels.


