REPORT ON STATUS OF FIDE ENDORSED ACADEMIES

We conducted a comprehensive academy rationalization program - over an eight-month period — as instructed, after the Q1 Presidential Board Meeting that was held in Kazakhstan was informed by accounts that there were many FIDE Endorsed Academies in long standing arrears.

Many of these did not even appear in the list of 64 academies given to use as current by the previous TRG Secretary, and even in this list we later discovered many inconsistencies.

At the end of this exercise, the 70+ academies became just 30, and with new academies joining over the course of the year, 5 of which were awarded at the FIDE Congress 2020 in Abu Dhabi, we had at the start of 2020, a total of 39 academies

Currently the 39 academies can be categorized as follows:

- 1. Only 17 academies can be said to be in full compliance. But this could be 19 as there are two (2) academies claiming to be given the privilege of being free for life, certainly an extraordinary situation and not defined by the current regulations.
 - We ask the FIDE Council to decide if this should continue, failing which we would recommend that these academies shall be struck off the FIDE academies list and their activity as FIDE academies shall be deemed seized unless they transfer the full amount of their debt before 15 July 2020.
- 2. 12 academies are not in compliance due to being in arrears of which five (5) academies have actually submitted their annual reports and one (1) academy has asked for a three-month extension in April to the end of June 2020 to be able to pay with the reason being they have had to suspend activities for several months due to the impact of the current global pandemic.
 - We recommend that that these academies shall be struck off the FIDE academies list and their activity as FIDE academies shall be deemed seized unless they transfer the full amount of their debt before 15 July 2020.
- 3. Five (5) other academies are not in arrears but who have yet to submit their annual report.
 - We believe to have a status of a FIDE academy, that this is an equal minimum obligation to the making of payment of their subscription and so would recommend that such academies shall be struck off the FIDE academies list and their activity as FIDE academies shall be deemed seized unless they submit due reports before 15 July 2020.
- 4. There are two (2) academies that are new which we understand did not fully appreciate the financial obligations involved and are likely to withdraw.
 - We recommend that that these academies shall be struck off the FIDE academies list and their activity as FIDE academies shall be deemed seized unless they transfer the full amount of their debt before 15 July 2020.

Dear Willy. I sent to you TRG Report with some important additional comments from my side.

I think it will be better to sent this letter to FC members today or tomorrow, so, all members will have enough time.

I would like to add on my own behalf that the Commission has done a lot of work with Academies, and that as a Legal Advisor, I believe that if the Academy does not perform its duties for a long time, it should lose its rights.

Current problems with Academies can be divided into several sections.

1. A number of Academies have not paid the annual fee for the year 2020 (200 euros), although the term of payment expired in April. It is assumed that if the debt is not repaid by June 16 (the date of the next meeting of the Council), these academies will lose their status.

I would like to emphasize a few important points.

a) in all cases, if the academies themselves apply to the TRG and ask for a reasonable delay in payment (for example, due to the fact that the Academy's financial situation has deteriorated), such a delay will be granted. However, in this case the Academy must take the initiative and ask the Commission to do so.

Unfortunately, the problem with non-payers is mainly that they simply do not respond to emails.

b) just in case, to ensure that the Academies are informed (perhaps some of them have a problem with the e-mail), we plan to publish a corresponding announcement on June 2 or 3 (in a polite tone, of course) on the FIDE website and FIDE social networks.

If members of the Council have a connection with some debtor academies, we would welcome their assistance.

In particular, for this purpose, publication on the FIDE.com will be postponed for a week from the date of this letter.

- 2. Some Academies have not submitted annual reports, although these reports are extremely simple (I enclose samples of these reports). These Academies are given an additional month (until July 15) to submit reports, otherwise they also lose their status. They will also be included in an informational publication on the FIDE website.
- 3.Two Academies with extensive experience and history claim to be entitled to "lifetime" status without making payments. The Council is invited to decide whether this status is confirmed.
