The Pandemic situation at all over the world directly and fully effected our commission events.

Our proposal of moving our 2020 tournaments to 2021 and moving 2021 tournaments to 2022 had approved by the Council. I would like to mention that we communicated with all the organizers for this proposal in advance.

We are planning to open bidding procedure for the 2023 events at the first months of 2021 by the approval of Council.

COOPERATION BETWEEN EVENTS COMMISSION AND EVENTS DEPARTMENT TO CREATE NEW ORGANIZATION DOCUMENTS

Events Department prepared some new documents with the cooperation of Events Commission.

We worked together on that documents and after discussions we sent those draft documents to Events Commission members to take their comments.
